As of September 30, 2001, the fund had a market value of \$64,594,910 including accrued income. This represented a decrease in value from the previous quarter of \$7,486,880 due to investment earnings and cash flow. The total fund earned -\$3,983,688 and paid out \$3,503,192 in net distributions.

As of September 30, 2001, 53.4% of the fund was invested in equities, 45.3% in bonds, and 1.2% in cash and equivalents. The allocation to stocks was only slightly more aggressive than the median fund.

For the quarter, the fund earned a -5.7% return, which ranked in the Bottom 46% of other public balanced funds.
