He said he had talked with Mr. Palmquist and understands the plan gets charged for each individual person; the more you have, the cheaper the calculations. He said he would try to coordinate calculations for them, but it would be their responsibility to pay Mr. Palmquist.

The Board Attorney gave an update regarding the progress on transfer of Division II funds into Division I for funding benefit enhancements to comply with 185. He said a request for transfer of funds has been forwarded to Division II and was approved by Division II at the last board meeting. He instructed the Board Secretary to do a follow up to ensure funds were transferred.

2. Update Boards regarding questions raised by Mr. Brinkman, Division of Retirement

The Board Attorney gave an update regarding the State and the annual report. He said he had talked with Division of Retirement as it relates to Judi Fleming and the dispatchers. He said he has a verbal agreement from both Mr. Brinkman and Ms. Shoemaker, that as far as Division I goes, Ms. Fleming is retired and there is no way we can stop distributing her benefits, even though she is in the DROP Plan. He said the Division of Retirement has requested documentation stating she has had law enforcement responsibility in the past.

He said he also had a conversation with the attorney for Division II and discussed the need to forward minutes and correspondence indicating that Ms. Fleming and others, who had already retired, but received benefits, were grandfathered-in. He commented that he is currently arguing on behalf of dispatchers, who are in the plan now and are basically grandfathered-in. He said they should be allowed to stay in the plan until they retire.

The Board Attorney also discussed employees transferring from one plan into the other. He said the State wants impact statements done anytime this happens and that an ordinance amendment needs to be done to allow the time in both plans to count towards vesting. Pg. 12, ERB/PRB Minutes, 08-27-2003
