She said she was concerned that people were not getting correct information, asked the Actuary how much it would cost for him to calculate final cost, and was told \$200 - \$300 per calculation; however, he could do a review for an unlimited number of people for \$300.

Ms. Costello explained the Finance Department had formulas in the computer that calculated average final compensation, but she preferred having the Actuary come to the Finance Department for training to verify that calculations were done correctly.

Officer Bouchard asked if the Actuary could create a chart much like the one created for military buyback and suggested requesting the Actuary conduct quarterly reviews.

Mr. Allen asked if recommendations could be brought back to the next meeting.

(3.) Letter dated November 21, 2005, from Pasco Testa, regarding interest on his rollover to Nationwide and request Merrill Lynch calculate amount of interest the pension fund made during the period of September 30 – October 12, 2005

Lengthy discussion ensued regarding the rollover of Mr. Testa's money into a Nationwide account because of errors on the checks. The checks were made out to Mr. Testa instead of the financial institution and in conflicting amounts. Checks were finally deposited on October 13, 2005, and Mr. Testa was seeking the amount of interest his money earned during the time it was left in the City's fund and the amount of lost interest on the money for the next 20 years.

Mr. Testa explained that checks had been made out incorrectly. He said they were made out to him instead of the financial institution, and the amounts were not consistent so he refused to endorse them. Checks were finally deposited into the financial institution on October 13, 2005. He asked the Board to give him the greater amount of interest the City's fund made for the 12 days or the amount of interest his Nationwide account would have made for 12 days in the amount of \$407.84, calculated by Nationwide Actuary, and an estimated amount of \$750.00 of lost interest on the money for the next 20 years.

The Board Attorney explained he was contacted by the City's Labor Attorney regarding an ordinance amendment to allow the City to enter into a settlement agreement with Officer Odum for retirement. He said it did not matter whether or not the Board approved this action, the City had the authority to proceed with the settlement agreement and ordinance amendment without an impact statement.

The Board Attorney said he requested information from Delray Beach regarding Mr. Edward (Ted) Siedle's investigation of their pension plan, but had not received anything at this time.

He discussed the Police plan's 185 funds. He said the money received from the State this year might be less than last year's amount because of the ordinance amendment and the restructuring with the database in which money might be shifted from one municipality to another. The money received in 2005 was for 2004 and was locked in place for the next 3 years.

He presented a check in the amount of \$29,165.40 for the subrogation agreement settlement for Bob Gross and said the plan needed a signed release for the funds.
