  - 1. Investment Consultant: Quarterly Performance Report

Tim Nash started his presentation with a brief overview of AndCo, noting that his firm receives a fixed rate for their consulting services. Mayor Betty Resch inquired about investments that are socially and environmentally conscious. Mr. Nash informed Mayor Resch that the Plan does not have any dedicated environmental and social conscious allocations; however, American Realty Advisors does adhere to social and environmental standards. Mr. Nash then reported on the performance of the markets over the past quarter and calendar year to date. Nash continually rebalances the portfolio with cash flows used to pay benefits and expenses, so the current asset allocation falls within Policy target ranges. Mr. Nash further reviewed the cash flows for the quarter for both the Employees Retirement System and the Police Officers Retirement System. The Employees Retirement System ended June 31, 2021 with \$81,459,238 of invested assets, a return of 4.99% gross and 4.89% net of expenses compared to 5.91% for the benchmark. Police ended the quarter with net assets of \$42,099,861, a net gain of 5.10% compared to 5.91% for the benchmark. Tim Nash reported that most managers performed well except for Sawgrass Large Cap Growth. Mr. Nash then reviewed the decision to terminate Sawgrass and move those funds into MFS Financial along with the switch from Vanguard over to the Fidelity Index ETF Fund, noting that Sawgrass has been liquidating the portfolio for the transfer over to MFS. Trustee Christopher Johnson inquired about annuities for a closed Pension Fund. Mr. Nash stated that the Board briefly considered utilizing annuities a while ago; however, now is not the time to purchase annuities due to the current low interest rates being offered on these products. Mr. Nash then stated that the Police Officers' Retirement System will migrate to a more conservative approach as the active members retire. Mr. Nash reviewed the performance review and compliance checklist for both Plans.

### D. Board Attorney's Report:

#### Attorney Report - Pedro Herrera, Sugarman & Susskind

Attorney Pedro Herrera informed the Board that Attorney Ken Harrison had a health issue about ten days ago that has prevented him from attending the Board Meeting.
