a. Investment Consultant Report - Scott Owens & Andy McIlvaine, Graystone Consulting

Mr. Mcllavine reviewed the economy for the quarter at length. The market continues to be very volatile; 8 out of the 11 sectors were positive, with healthcare, energy, and material as detractors.

Fire Summary of Relevant Facts

Mr. Owens reviewed the 09-30-19 quarterly report. The total portfolio was \$22,192,019 with a net rate of return of 0.33%. There is currently no need for rebalancing. Mr. Owens reviewed the Plan's managers and the compliance checklist. The total portfolio as of 11-01-19 was \$22,715,610 with a net rate of return of 1.6% FYTD. Mr. Owens reviewed the tactical asset allocation and Morgan Stanley's outlook going forward.

Police Summary of Relevant Facts

Mr. Owens reviewed the 09-30-19 quarterly report. The total portfolio was \$17,147,192 with a net rate of return of 0.45%. Mr. Owens reviewed the Plan's managers and compliance checklist.

b. Attorney Report - David Robinson, Sugarman and Susskind, PA

The Boards requested that Mr. Robinson combine the Fire ordinance changes into 1 ordinance and the Police changes into 1 ordinance. The Summary Plan Descriptions will be updated after both ordinances are passed.
