a. <u>Investment Consultant Report</u> – Scott Owens and Andy McIlvaine, Graystone Consulting

Mr. McIlvaine provided a brief update on the market; it was a strong quarter. Interest rates continue to rise and inflation is at a 40 year high.

Fire Summary of Relevant Facts

As of 12-31-21, the total portfolio was \$31.16 million with a fiscal year rate of return of 4.35%. The total

portfolio as of 02-01-22 was \$30.2 million with a 0.9% fiscal year to date.

Police Summary of Relevant Facts

As of 12-31-21, the total portfolio was \$23.4 million with a 5.06% fiscal year to date net rate of return. The total portfolio as of 02-01-22 was \$22.1 million with a 1.9% fiscal year to date return.

Mr. Owens reviewed the asset allocation, individual manager performance, and the compliance checklist for each Plan. There are no recommendations for change at this time.
