#### 3. PUBLIC COMMENT

Mr. Sheffield does not live in the City of Marco Island, which conflicts with the ordinance language. The City Council Chairman wanted to be on the Boards, but the City Attorney said it was a conflict of interest; the City needs to appoint an individual. The Board reminded Mr. Sheffield of the meeting attendance requirement for the new Trustee and that this matter needs to be expedited as it is difficult to maintain a quorum; Fire only has 2 Trustees present at this time and 3 is needed for a quorum.

#### a. <u>Actuarial Valuation</u> – Jeff Amrose, GRS

Jeff Amrose, GRS – Electronic Mike Sheffield, City Clerk Plan Members Mr. Amrose presented the 2021 Fire Actuarial Valuation; the Plan is in excellent shape with a funding ratio of 118%. The City's funding requirement is 32.73%; the Plan sponsor must pay the normal cost. The Board has adopted smoothing assets and a DROP Plan has been established. The Plan will not lose State monies as it is not closed.

#### b. Investment Consultant Report –Andy McIlvaine and TJ Lowe, Graystone Consulting

Mr. McIlvaine provided a brief update on the economy and reviewed the international growth manager search.

#### Police Summary of Relevant Facts

As of 06-30-22, the total portfolio was \$20.35 million with a -9% rate of return.

#### **Fire Summary of Relevant Facts**

As of 06-30-22, the total portfolio was \$27.58 million with a rate of return of -9.20%.

Mr. McIlvaine reviewed the individual managers and asset allocation.

#### <u>POLICE:</u> MOTION TO REDEEM \$250,00 AND ALLOCATE TO LARGE CAP GROWTH WAS MADE BY MR. ZIRGIBEL AND SECONDED BY MR. MONTGOMERY. THE MOTION PASSED UNANIMOUSLY.

#### c. <u>Attorney Report</u> – Pedro Herrera and Caroline Quill, Sugarman and Susskind, PA

There is a pending bill that affects first responders that lowers Medicare age from 65-60; it will not affect the Plan. The FPPTA and Division of Retirement have upcoming conferences.
