5. <u>REPORTS</u>

a. <u>Manager Presentation</u> – Steve Votto & Jeffrey Layne, Clearbridge

Mr. Layne provided a firm update; this is a large cap growth strategy. They will continue to diversify from the benchmark and a recession is forecasted for next year. The Boards discussed the portfolio holdings and fees at length.

Mr. Votto and Mr. Layne left the meeting at 9:43 AM.

b. <u>Investment Consultant Report</u> – Scott Owens, Graystone Consulting

Mr. Owens explained the process of how potential managers are selected and brought to the Board. The Board discussed the asset allocation and market.

Police Summary of Relevant Facts

As of 09-30-22, the total portfolio was \$19.6 million with a -10.75% rate of return for the fiscal year. The total portfolio as of 11-01-22 was \$20.7 million with a 4.6% rate of return.

Fire Summary of Relevant Facts

As of 09-30-22, the total portfolio was \$26.9 million with a rate of return of -11.79% for the fiscal year. The total portfolio as of 11-01-22 was \$28 million with a 4.3% rate of return.

Mr. Owens reviewed the individual managers and asset allocation. The Board will review a manager search next meeting.

c. <u>Attorney Report</u> - Caroline Quill, Sugarman and Susskind, PA

Ms. Quill informed the new trustee that the Board is subject to the Sunshine Law. No legislature has passed that is expected to impact the Plan at this time. Ms. Quill reminded the Board of upcoming Trustee educational opportunities. In lieu of holiday gifts, the firm has donated on the Board's behalf to the Red Cross Hurricane Ian Relief Fund.

d. Administrator Report - Amber McNeill, The Resource Centers
