Quarter in Review—1Q 2023

As of March 31, 2023

First quarter equity returns improved since the end of 2022. For the quarter, growth stocks outperformed value stocks, and large-cap outperformed small-cap. The Dow Jones Industrial Average rose 16.0% while the Russell Midcap gained 9.2%, the S&P 500 improved 7.5%, and the Russell 2000 Small-Cap Index increased 6.2%.

During the first quarter of 2023, China reopened following the pandemic, consumers remained resilient, and various central banks continued to respond with tightening measures to fight elevated inflationary pressures in services and wages. While news of technology sector layoffs reached headlines at the start of the quarter, labor markets were healthy and economic growth remained robust. Equity markets seemed to believe that inflation was softening without much of a sharp pullback in growth, thereby enabling a Fed pivot and possibly a "soft landing"-or "no landing" at all. Meanwhile, equities and fixed income markets were not aligned. As expectations for interest rates declined, valuations rose, short-covering picked up, and one-day options activity surged. Equities appeared to look through potential risks for an economic and/or profits recession. Following seven rate hikes in 2022, the FOMC raised rates a total of 50 basis points during the quarter: 25bps in February and 25bps in March, while the QT program continued. Together with tighter financial conditions from banks, these monetary effects caused tightening in financial conditions, which threatens to slow economic activity. Self-inflicted liquidity stress among US regional banks came to the forefront, raising investor concerns about recession. Nonetheless, once government authorities ensured support for the US banking system, markets responded quickly with a focus on the stability of the US banking system regulations. US equities ended the quarter higher, as growth outperformed value, and large cap outperformed small. Nevertheless, the 10Y2Y yield curve remained inverted and the Fed ensured commitment to taming inflation through rate hikes and tightening financial conditions. By the end of 1Q23, the Bloomberg US Aggregate Index improved 3% and gold rose 8%, while WTI oil declined 5.7%, and the US dollar Index gained 1.2% over the same time period.

Across the globe, equities in regions outside the US were mixed, as MSCI Europe improved 10.4% while Asia Pacific ex Japan rose 2.6% and Emerging Markets increased 4.0% in USD. The US dollar posted a -1.31% total return since December 31, 2022.

For the S&P 500, seven sectors posted positive returns for the 1Q versus the close on December 31, 2022. The Information Technology (+21.8%), Communication Services (+20.5%), and Consumer Discretionary (+16.0%) sectors improved relative to the S&P 500. Meanwhile, the Materials (+4.3%), Industrials (+3.5%), Real Estate (+1.9%), Consumer Staples (+0.8%), Utilities (-3.2%), Health Care (-4.3%), Energy (-4.7%), and Financials (-5.6%) sectors underperformed the S&P 500's 7.5% 1Q23 rise.

The Fed continued with its rate hiking campaign and raised rates another 25 basis points in February and 25 basis points in March 2023. Since March 2022, the Fed announced nine rate hikes, for a total of 4.75 percentage points. The yield on the 10-year US Treasury note closed the first quarter at 3.47%, down from the 3.87% at the end of the fourth quarter while the 2Y10Y yield curve inversion lessened. The yield on 3-month Treasury bills was 4.69%, up from 4.34% at the end of 4Q23. The Bloomberg US Aggregate Bond Index, a broad measure of the US bond market, rose 3.0% in 1Q23 after posting a -13.0% return in 2022.

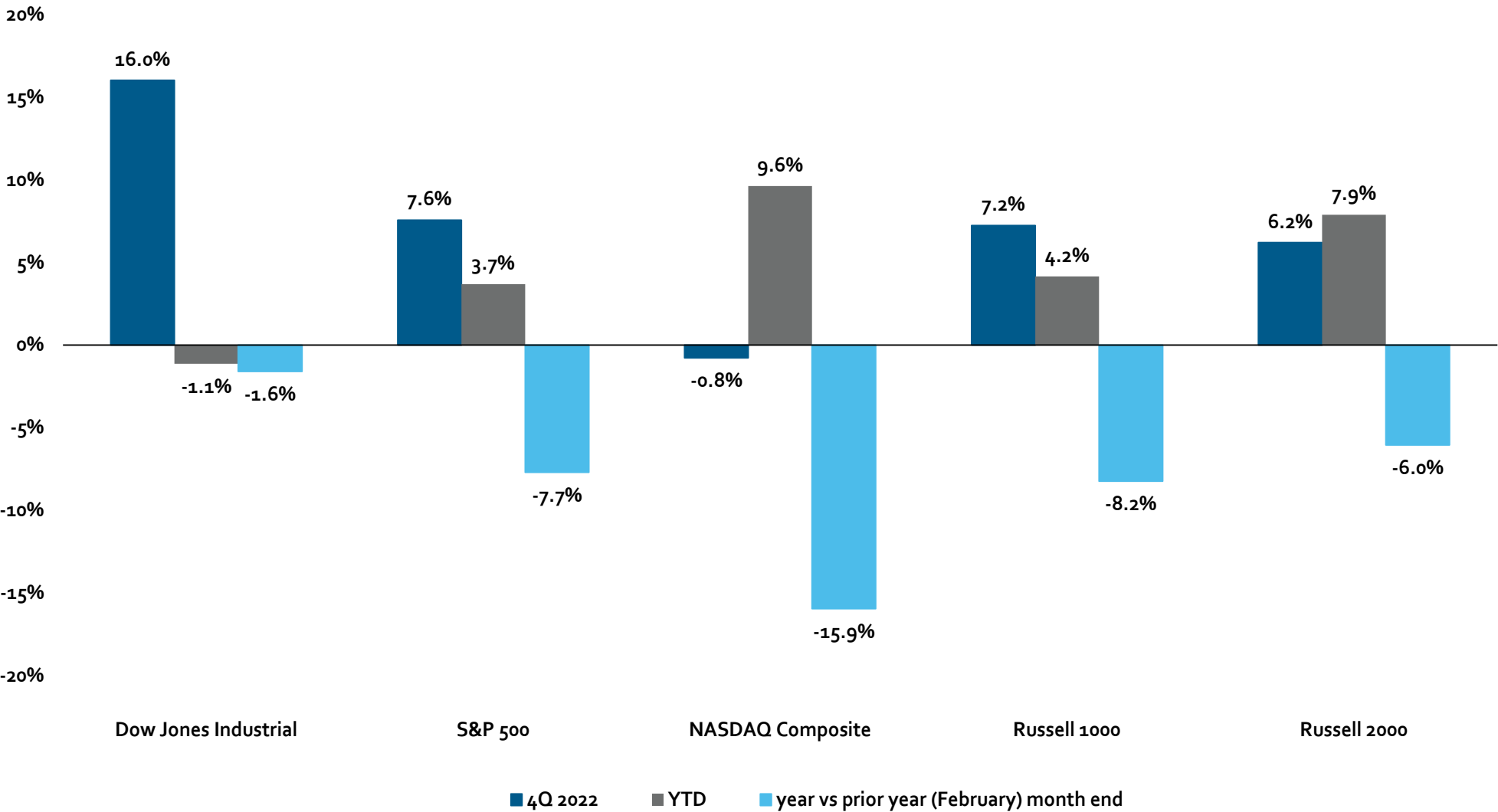

As of February 28, 2023



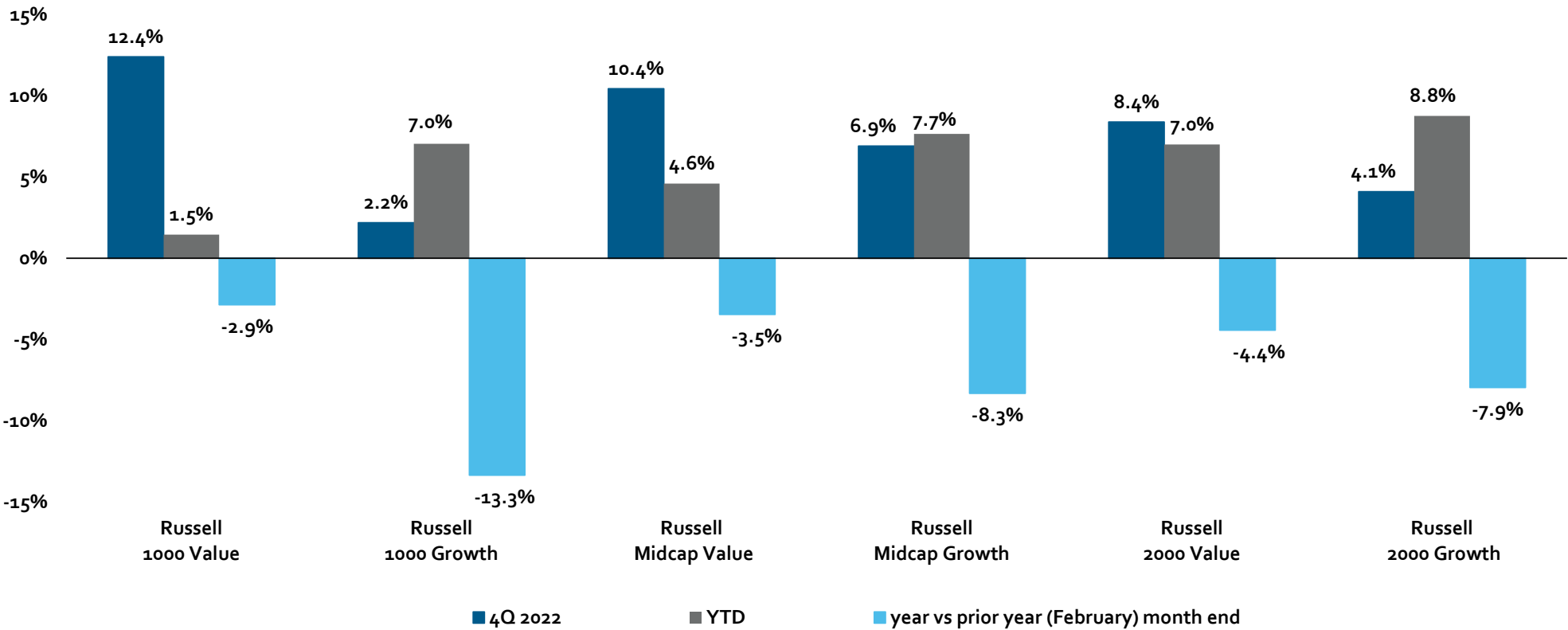

As of February 28, 2023

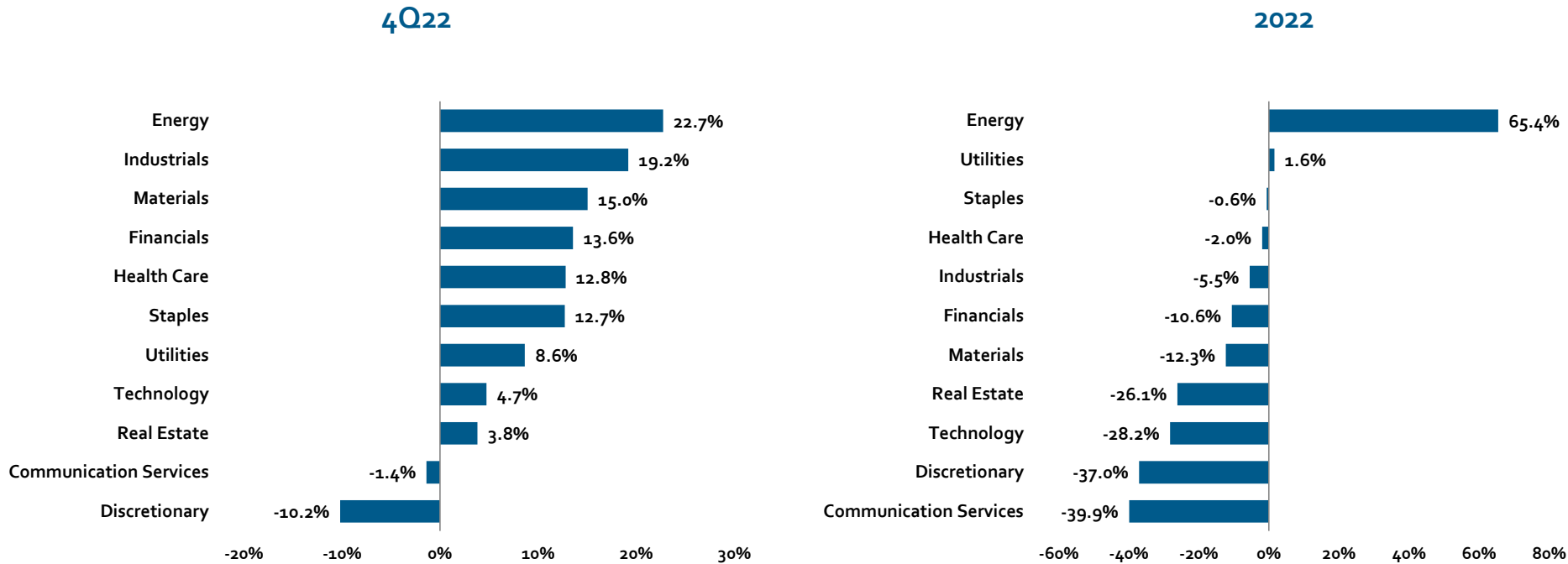

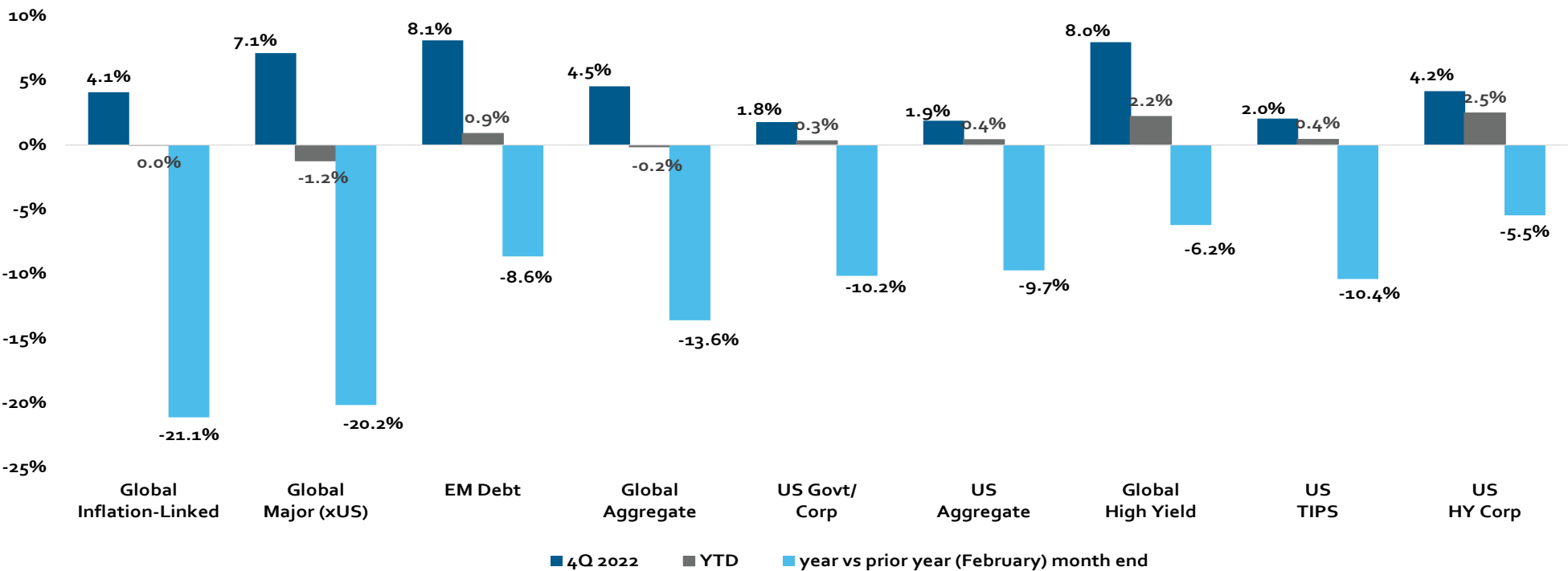
S&P 500 Sector Total Returns

Self-selection bias results when certain manager returns are not included in the index returns and may result in performance being skewed up or down. Because hedge funds are private placements, hedge fund managers are able to decide which fund returns they want to report and are able to opt out of reporting to the various databases. Certain hedge fund managers may choose only to report returns for funds with strong returns and opt out of reporting returns for weak performers. Other hedge funds that close may decide to stop reporting in order to retain secrecy, which may cause a downward bias in returns.

Survivorship bias results when certain constituents are removed from an index. This often results from the closure of funds due to poor performance, “blow ups,” or other such events. As such, this bias typically results in performance being skewed higher. As noted, hedge fund index performance biases can result in positive or negative skew. However, it would appear that the skew is more often positive. While it is difficult to quantify the effects precisely, investors should be aware that idiosyncratic factors may be giving hedge fund index returns an artificial “lift” or upwards bias.

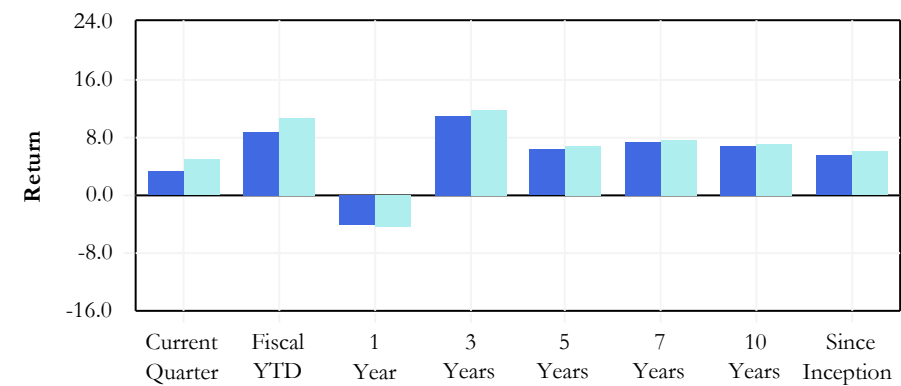

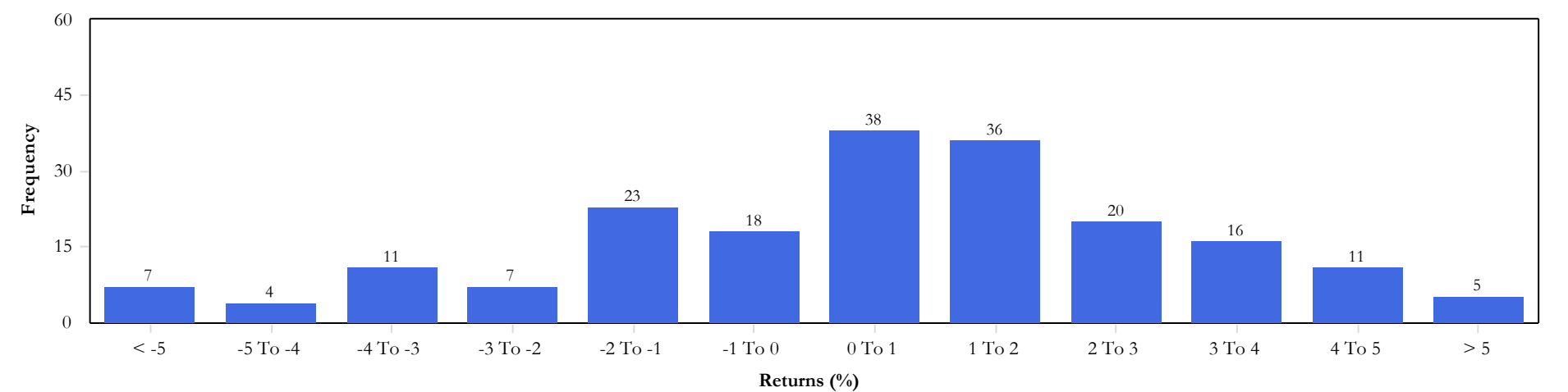

Distribution of Returns



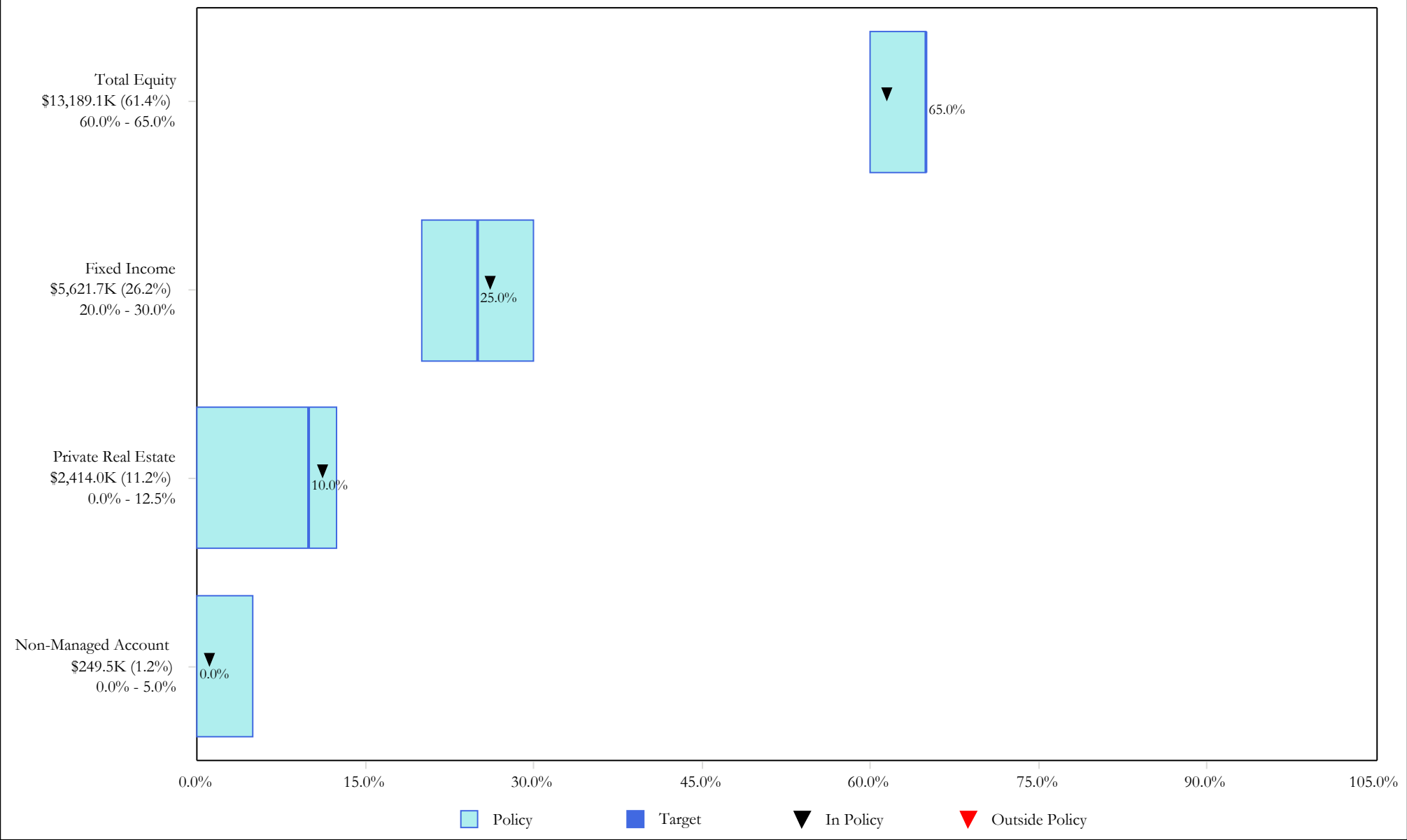

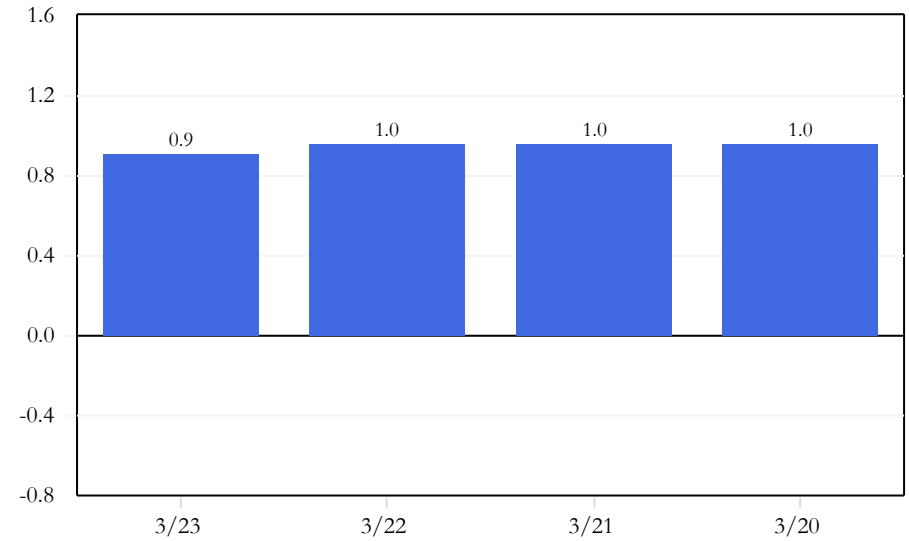
Total Fund - Rolling Three Year MPT Statistics

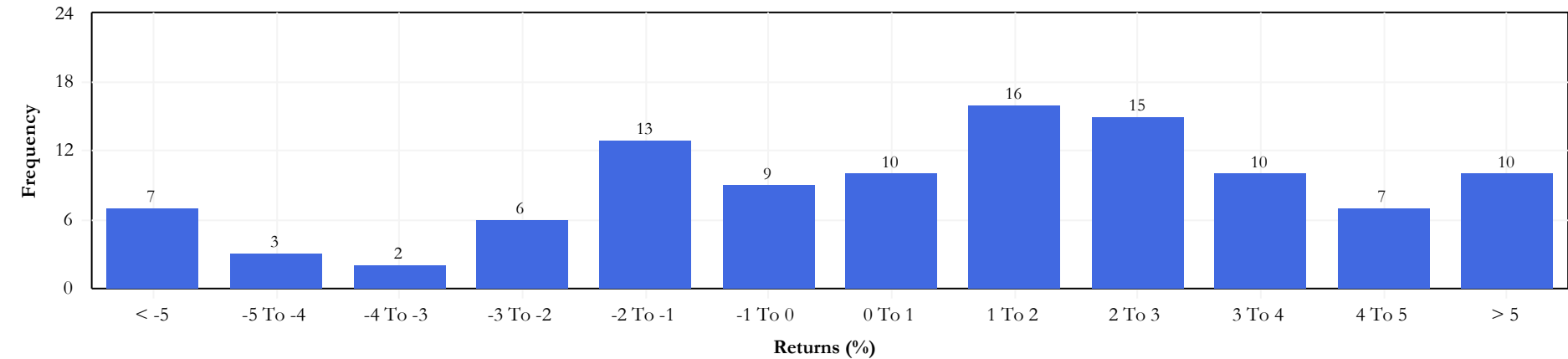

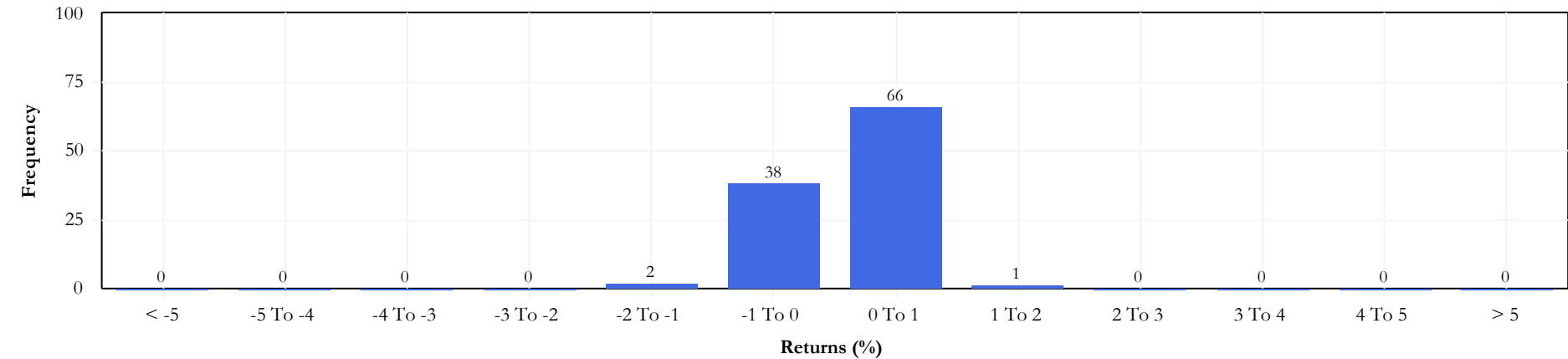

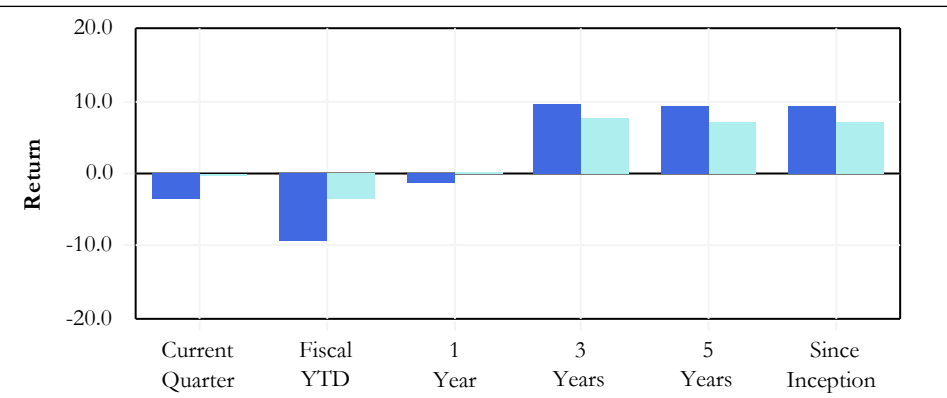

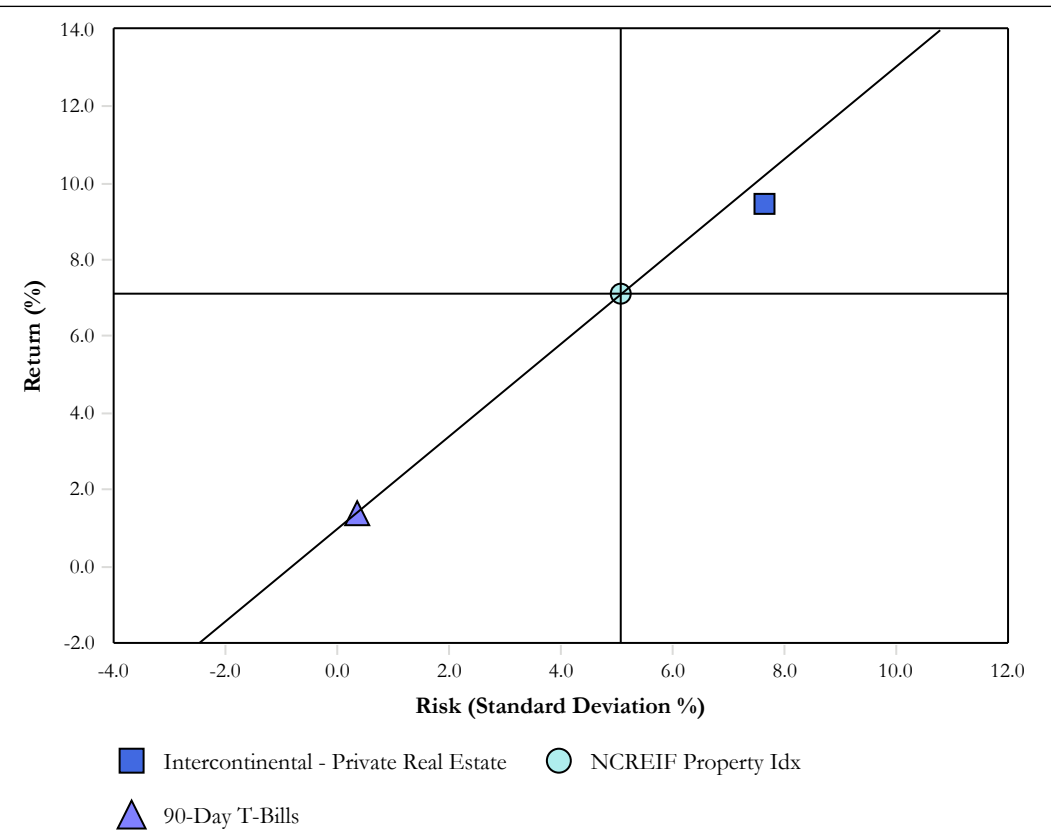

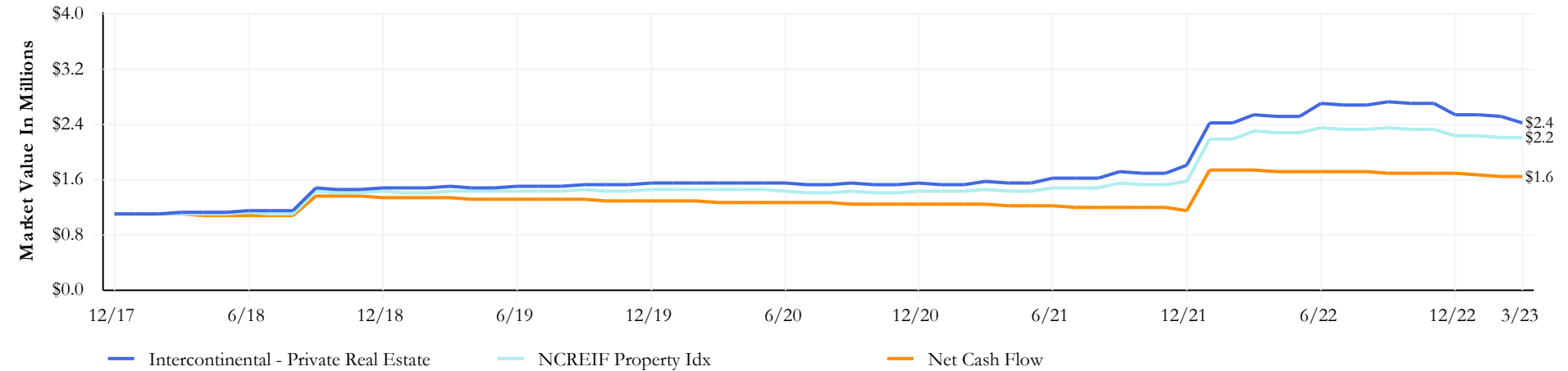

as of March 31, 2023

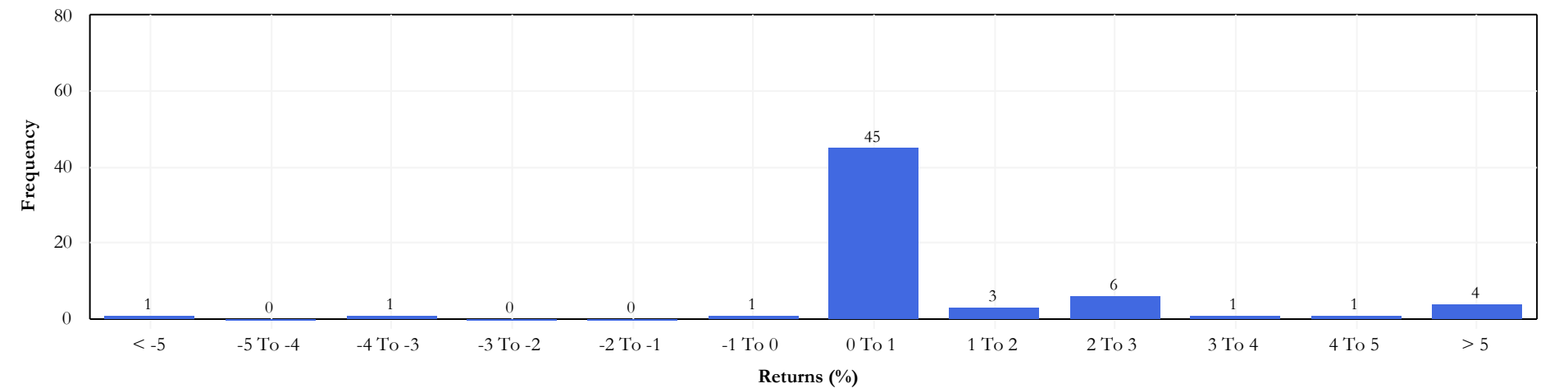

Peer Groups

Peer Groups are a collection of similar investment strategies that essentially group investment products that share the same investment approach. Peer Group Ranking Methodology

A percentile rank denotes the value of a product in which a certain percent of observations fall within a peer group. The range of percentile rankings is between 1 and 100, where 1 represents a high statistical value and 100 represents a low statistical value.

The 30th percentile, for example, is the value in which 30% of the highest observations may be found, the 65th percentile is the value in which 65% of the highest observations may be found, and so on.

Percentile rankings are calculated based on a normalized distribution ranging from 1 to 100 for all products in each peer group, where a ranking of 1 denotes a high statistical value and a ranking of 100 denotes a low statistical value. It is important to note that the same ranking methodology applies to all statistics, implying that a ranking of 1 will always mean highest value across all statistics.

For example, consider a risk/return assessment using standard deviation as a measure of risk. A percentile ranking equal to 1 for return denotes highest return, whereas a percentile ranking of 1 for standard deviation denotes highest risk among peers.

In addition, values may be used to demonstrate quartile rankings. For example, the third quartile is also known as the 75th percentile, and the median is the 50th percentile.
