<u>CONTUNIATION OF DISABILITY HEARING FOR MR. ANDREW GRANT JR</u>

The board briefly reviewed the case background and Mr. Moore spoke about the workmen's comp that the City provides to individuals that are hurt on the job. They encourage them to stay at work and if they can't find a fit job for the employee at the City then they will seek outside help. Ms. Barnard commented that it seems to her like Mr. Grant and also his treating physician says that whatever job position he does that he will always be in pain and taking medication. Mr. Rodger was asked about his performance at work since he is his supervisor. Mr. Rodger's responded that his performance is outstanding as far as going about his daily routine, but you can see he is in pain. Mr. Sherman stated that he thinks that it is only fare to Mr. Grant and also the Trustee's to send him for another IME. The board had a lengthy discussion on the purpose of sending him for another IME when his treating physician of 15 years has stated that he is totally and permanently disabled.

A motion was made by Randy Sherman to authorize sending Mr. Andrew Grant Jr. to an outside doctor of the pension board's choice for an IME. The motion was seconded by Bill Swisher and carried 4-3.

The Trustees discussed how they are going to choose what doctor to send Mr. Grant to. They noted that in the past Mr. Levinson would choose a doctor off his list and set up the appointment. Ms. Ross noted that she would
