# THE CITY OF WEST PALM BEACH RESTATED EMPLOYEES' DEFINED BENEFIT RETIREMENT SYSTEM MINUTES OF MEETING HELD August 25, 2020

A regular meeting of the Board of Trustees was called to order at 2:40pm by Chairman Benny Rodgers via RingCentral Video Conference.

#### **MINUTES**

The Board reviewed the minutes from the regular meeting held on May 26, 2020.

A motion was made by Mark Parks to approve the minutes from the regular meeting held on May 26, 2020. The motion received a second by Christopher Harrison and was approved 4-0.

#### <u>INVESTMENT CONSULTANT REPORT – ANDCO CONSULTING</u> (PRESENTED BY: John McCann)

John McCann presented the Board with the Quarterly Investment Consultant Report. Mr. McCann stated his presentation by reminding the Board that the quarter ending March 31, 2020 was horrible due to the COVID-19 Pandemic. For the quarter ending June 30, 2020 the Plan was up 12.81% net, compared to the benchmark of 13.79. For the Fiscal Year to Date, the Plan is up 2.20%, compared to the benchmark of 5.08%. The market value of the Plan on April 1, 2020 was at \$39,828,243. The total net transfers for the guarter were \$21,642, contributions were \$13,534, and distributions were \$800,000. Management Fees totaled \$31.997 and other expenses were \$3,049. The total income for the quarter was \$222,984 and appreciation was \$4,879,564 bringing the market value of the Plan up to \$44,109,280. Mr. McCann then reviewed each individual manager, noting that he is keeping an eye on Argent Capital and Templeton. The markets are showing promise and Mr. McCann stated that he does not recommend any changes at the moment. As of July 31, 2020, the Fiscal-Year-To-Date net return is 5.8% and as of today, the Plan can add another 1.5-2%, bringing the Plan's Net return to 6-6.5%. Charmin Benny Rodgers inquired if Real Estate is of any concern. Mr.

McCann stated that he has been in constant contact with the Plan's Real Estate Managers and sees no concern at this moment.
